GEORGIA PRECEPTOR TAX INCENTIVE PROGRAM (PTIP)

Providing Value to our Volunteer Community-Based Faculty

What is PTIP?

- Community-based preceptors (licensed medical, osteopathic, advanced practice nurse, or physician assistant) who are not compensated for teaching, can earn tax credits for providing community-based clinical training for students from a Georgia public or private medical, osteopathic, advanced practice nursing, or physician assistant educational program
- Physicians can earn \$8500 in tax credits each calendar year
 - First 3 rotations earn \$500 tax credits each
 - Rotations 4 - 10 earns \$1000 in tax credits each
 - 160 training hours per credit
 - Max 10 rotation credits can be earned per year
- APRNs and PAs can earn \$6375 in tax credits a year
 - First 3 rotations earn \$375 in tax credits each
 - Rotations 4 - 10 earns \$750 in tax credits each
 - 160 training hours per credit
 - Max 10 rotation credits can be earned a year

How to Sign Up to Earn Tax Credits

-YOU MUST LET THE SCHOOLS KNOW YOU ARE INTERESTED IN EARNING TAX CREDITS

Here is how:

- **Step 1:** Register here:

- **Step 2:** Let the schools you work with know that you are interested in receiving tax credits. They are the ones who enter the credits
- **Step 3:** Check with the schools you work with and make sure all rotations are accounted for BEFORE the end of the calendar year
- **Note:** If you are splitting rotations with other preceptors, let the schools know so they know how to split up the credits

 - Cannot receive tax credits for teaching residents
 - Must be licensed in GA
 - Cannot receive direct compensation from any source, for teaching medical, osteopathic, APRN, or PA students

Certification of Tax Credits

- The Statewide Area Health Education Centers (AHEC) Program Office at Augusta University shall administer the program and certify rotations
- **Only** the AHEC Program Office can certify eligible rotations and issue tax letters
- Individual academic programs will report completed qualifying hours to the AHEC Program Office
- Credit will be certified by the Georgia Statewide AHEC Network Program Office and a letter issued by January 30 of each calendar year
